Over the past several years, I have been working on a book on the ethics of immigration and have concentrated my reading and research on work closely related to this topic. Having completed that project, I want to branch out a bit. The works that I have chosen for this course are eclectic. What they have in common is that, with two exceptions, they have been written in the 21st century and I have reason to believe that they will be interesting and illuminating. I'll say a bit more about each of the assigned readings at the beginning of the week in which it is discussed, but this will be a discussion course, not a lecture course. You are expected to come to class familiar with the texts and ready to engage with them.

## **COURSE REQUIREMENTS AND GRADING:**

- 1. Active and informed participation in class discussion. (10% of course grade)
- 2. 3 short papers responding to the readings. You may discuss a single author or two different authors in each paper. Each paper is worth 30% of the course grade.

For undergrads, the papers should be 5-6 pages in length (12 pt. font, 1" margins, double spaced). For graduate students, the papers should be 7-8 pages in length. (same formatting as undergrads). Please submit your papers to me electronically in .doc or .rtf format.

You may choose the authors whom you wish to discuss, but you must submit at least one paper before the February break (i.e., one on Pettit or on Brown or on both). The papers are due on the Tuesday following the final class during which the author is discussed.

I do not prohibit late papers but they are subject to penalties. Late papers will be penalized one point per day including weekends, unless an extension is explicitly granted in writing in advance.
