# Preliminary Course Description

European integration is one of the most important political experiments in recent history. This course looks at the historical impetus for European integration and to the recent trends in this process, as well as its future prospects. It will examine the consequences of enlargement and deeper integration for the internal dynamics of the Union. However, the emphasis is on the impact that integration and the prospects of integration have on the potential member states and the countries bordering the Union.

The course provides a brief overview of the salient issues in the past enlargement rounds, furnishing the context for the study of current and future integration efforts. Readings will cover the recent rounds (2004 and 2007) of enlargement to the Central and East European countries, continuing with efforts related to South-Eastern Europe (the Balkans), as well as Turkey. Of particular focus this year will be the impact of the enlargement to Bulgaria and Romania on the Western Balkans.

Issues between the EU and Ukraine and Russia will also be studied, as will the relationship between the Union and its Southern Rim (North Africa and the Middle East). Security issues, related to NATO integration and operations, will also be covered. In addition to an introductory session, there are six sections: (i) Underdeveloped Latecomers, (ii) Central Europe, (iii) The Balkans and Eastern Europe, (iv)Turkey and the Mediterranean Area, (v) Boundaries, Identities and NATO and (vi) The Contemporary EU.

#### **GRADING SCHEME**

There are four components to the grade for the course:

1<sup>st</sup> term essay (1000 words) - 25% - Due 26 October 2010 – This is an essay that should be designed as an opinion piece on an issue of central importance for the EU. We will discuss the format in detail in class. Students are encouraged to familiarize themselves with this style of essay.

In-class Test 20% – Last class end of First term. Short answer questions – identify and explain the significance.

 $2^{nd}$  term essay (3000 words) - 45% – Due TBA. This is a more classical research essay. It must be on approved topic discussed with me in advance.

Regular attendance and participation – 10%.

Late penalty is 2% per day.
