This is an upper level seminar on collective identity and the politics of identity. It covers a range of “identities,” including gender, ethnicity, sexuality, and race, as well as a number of distinct theoretical perspectives on how to think about the issue of identity in politics.

Course requirements:

1) Two 4-page reading response papers, due at noon on the Friday before the reading will be discussed in class. One of these papers must be submitted by February 15. Late papers, handed in after the class that covered that reading, will not be accepted. These short papers should be emailed directly to me at courtney.jung@utoronto.ca.

Format: these short papers should critically engage the reading. Although they are brief, they should be real “papers,” with an argument, an introductory paragraph, and a conclusion – they should not take the form of a series of interesting questions, or of “thoughts” or “ideas” you had when you were doing the reading.

Each of these papers will be worth 20% of the grade.

2) One final 20-page paper, due the last week of class. This paper may be on almost any topic related to identity – it may be a research paper, a theoretical paper, or a literature review. Students are **REQUIRED** to meet with me during the semester to discuss their paper topic. Papers that have not been discussed with and approved by the instructor will not be accepted.

This paper will be worth 50% of the grade.

3) This is a seminar class. Students must complete all the reading, and come to class prepared to engage in discussion. Attendance in this course is mandatory. If a student misses more than one class without medical documentation, s/he will be asked to withdraw from the course. In-class participation will be worth 10% of the grade
