This seminar will focus on a topic that has recently acquired considerable academic interest and international attention, the subject of peacebuilding. Long after the military struggle of a civil war has ended and a peace settlement has been negotiated (or imposed), there remains the difficult task of rebuilding the war-torn society. The purpose of this seminar is to explore what this term means; how peace is restored, by whom and for what ends; and the many obstacles that arise to slow down and in some cases to disrupt the peace process. Throughout the seminar we will apply theories of peacebuilding to real-world cases.

REQUIREMENTS

1. The success of any seminar depends on the willingness of students to participate in the weekly discussions. Marks (**20%**) will be awarded to students on the basis of their general participation in the seminars and their individual presentation/leadership of a week's readings.
2. A critical review of one of the following books (2500 words), to be handed in by October 9, 2018 (30% of the final grade).
